## Global Value Chains and Africa's Industrialisation

The African Economic Outlook (AEO) 2014 presents the current state of economic and social development in Africa and projects the outlook for the coming two years. For the first time it provides comprehensive and comparable data and analyses for all 54 African countries. As in the past the 2014 edition comprises three parts. Part one assesses Africa's macroeconomic performance and prospects, financial flows and tax revenues, human development, as well as trade policies and regional integration. Part two focuses on this years specific theme: The role of global value chains and how they can contribute to Africa's industrialisation. Part three consists of comparable notes on each individual African country.

This years 13th edition of the AEO will be presented by senior experts from the African Development Bank and the OECD Development Centre
